The number of sections and students shall be restricted as per the actual facilities in the school.

Important Notes: 1. The total number of sections of the school shall be restricted to 21 (As per prescribed dimension) as per the number of class rooms reported during and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.

- 2. The school should provide separate toilets for CWSN boys and girls on every floor and submit compliance within 3 months on SARAS.
- 3. The school is required to make provision for toilets for staff separately and upload compliance within 3 months on SARAS portal.
- 4. The school should shift the library to a bigger room, as prescribed under byelaws. The school should create proper storage area and seating area in the 3 science labs and provide for a composite science lab for secondary level students. The school should follow the SoPs issued by the Board in respect of labs, library and sports facilities and submit compliance within 3 months on SARAS portal.
- 5. The School shall conduct mandatory training of its teachers with CoE Noida and submit compliance on SARAS portal.
- 6. The ramp shown to access the upper floors is made next to the stairs and is a wooden structure which is steep and dangerous for the CWSN students. The school shall take it down and construct a proper ramp from outside/inside the building as per norms in RPWD Act or provide for lifts within 3 months and submit compliance on SARAS portal.
- 7. The school is required to renew all the mandatory certificates from time to time and directed not to remove videography link in future.
