- XII. AMENDMENT SPECIFIC TO UTTAR PRADESH GOVERNMENT NORMS
 - The registered Trust/Society of the school will be renewed from time to time.

- (ii) There will be a nominated member by the director of education in school managing committee.
- (iii) 10% seats will secure reserved for the SC/ST students and from such students school will not charge more dues than that of prescribed by the secondary education board of Uttar Pradesh / Basic Education board.
- (iv) To maintain school managing process. No grant will be demanded from State Govt. The school is already affiliated to the Secondary Education board of U.P. and if the school is affiliated to the Central Board of Secondary Education, New Delhi/ Council for the Indian School Certificate Examination Board, New Delhi then in such situation its affiliation and allotted grant from Govt. of U.P. if any will automatically be cancelled.
- (v) The employees of the school will not be given less salary package and allowances than that of the employees working in State Govt. aided schools.
- (vi) The employees will be governed by service rules applied according to state Govt. procedure and all kinds of retirement benefits will remain available to the employees quietly parallel to state aided institution.
- (vii) School will remain abide by all rules prescribed by state Government from time to time for state Educational Institutions.
- (viii) School records will be maintained accordingly to the prescribed Performa's & registers affixed by state Government.
- (ix) School will not amend any of the above clauses in the by-law of school society without the permission of UP Government.
